- Proof of Income ('Preuves de revenus')
 - Salary slips ('Fiches de salaires') for the six preceding months.
 - Certificate of Employment and Income ('Attestation d'emploi et de revenus') signed by employer indicating Name, Address & Telephone number of the latter and also period of employment.
 - Bank Account and/or Statements ('Livret et/ou Relevé de compte/s bancaire/s') for the six preceding months/12 months for self-employed/daily worker.
 - Any other relevant document/s as may be required to prove and assess income.
 - Certificate/s / evidence/s of all Outstanding Credit Facilities with details.
- 2. Letter from Lending Institution confirming details of loan (as per Section G).
- 3. A location plan to help MHC Ltd's Technical Officer to find your property for valuation purpose and, if applicable, plans for proposed project / extension, together with relevant permits (Building, development, etc).

J. FEE

A non-refundable processing fee of **Rs 2,000/-** is payable at the time of Application.

K. NOTES TO APPLICANTS

- 1. Applicants are hereby informed that **no-permission** shall be granted in the following cases:-
 - (a) If existing loan accounts are in arrears.
 - (b) Where the total monthly commitments (i.e MHC Loan/s + other loan/s repayments) exceed 40% of applicant's monthly income.
 - (c) Where the total loan amount (i.e MHC loan/s + Other loan/s) exceed 75% of MHC's valuation of the property.
 - (d) When the loan may be obtained from MHC on the same or better terms.
- Applicants are also informed that the building Insurance cover will be updated to reflect MHC's present valuation of their property.
- 3. Any undisclosed or inaccurate information and/or missing document/s may unduly delay the processing of the application.
